

# Holliday Band Parents Association (HBPA)

Meeting: September 11, 2017

I. Call to Order: Anjela Schlegel called the meeting to order at 6:35.

II. Approval of Minutes: Motion made by Becky Perez, 2<sup>nd</sup> by Jill Anderson, to accept the minutes from the August meeting. Motion carried.

III. Standing Reports: a. Director's Report-Mrs. Hadderton reported that she was in discussion with Ponder for meal for the band students for the Friday night game at Ponder. d. Treasurer's Report-Becky Perez reviewed the treasurer's report. Paid HBPA memberships are up from last year. Online store appears to be worth the fees. HBPA received a bill for cookie dough from February 2016 for \$5800. After extensive research, it was determined that HBPA apparently never received the bill and will pay the \$5800.
